Family Bill of Rights

- · Children have the right to food, shelter, clothing, and to have their very basic needs met.
- · Children have a right to be as comfortable as is reasonable to provide, which includes access to medical care, clean diapers, and a quiet and safe place to grow and learn.
- · Children have a right to be recognized when they are crying, with the first assumption made that there is something wrong.

Safety, Security, and Protection:

- · Children have a right to depend on the adults around them for their needs.
- · Children need to be held, comforted, consoled, reassured, and protected.
- · Children have a right to informed medical decisions made by parents who understand, as much as is possible about the decisions: the risks, the pros, and the cons.

Social Needs, Sense of Belonging, Love:

- Children have the right to be loved
- · Children have a right to make mistakes, and to be forgiven for such.
- · Children have the right to behave in a manner consistent with being a child, which is curious, exploratory, persistent, stubborn, ambitious, capricious, and bold.
- Children have a right to learn by example, not by "do as I say, not as I do".

Esteem Needs, Self-Esteem, Recognition, Status:

- · Children have a right to a recognition of their innate intellectual and emotional intelligence.
- · Children have a right to express themselves in their own unique and independent way, regardless of the expectations of their parents.
- * Children have a right to not be burdened with, or help solve, adult issues and problems.
- · Children have the right to eschew the responsibility of making their parents "whole" or fulfilled..

· Children have the right to pursue religion and/or spirituality independent of their parents beliefs, including the choice to pursue neither.

Mom & Dad

- Parents have a right to make the best decisions they can to provide the basic necessities on behalf of
- · Parents have a right not to dangerously overextend themselves providing for their children, psychologically, healthwise, or financially.

Safety, Security, and Protection:

- · Parents have the right to make reasonable decisions on behalf of their children both as to what their children's needs are as well as how to meet them, even if this involves guessing.
- · Parents have the right to set the priorities of the family such that the basic needs of safety and protection are met first.
- · Parents have the right to make medical decisions on behalf of their children, all the way up to the point when the child is able to make said decisions for herself.

Social Needs, Sense of Belonging, Love:

- · Parents have a right to make mistakes, and to be forgiven for such.
- · Parents have a right to behave in a manner consistent with being an adult, despite how unpopular this will be for the child from time to time.
- · Parents have a right to learn as they go; we cannot know everything there is to know at the very beginning.

Esteem Needs, Self-Esteem, Recognition, Status:

- $ilde{\,}$ Parents have the right to devote time and energy to their own relationship, outside of the context of children, as this relationship is the foundation for the family
- · Parents have the right to celebrate the passage of time, to acknowledge their successes, and to learn from their failures.

Self-Actualization:

· Parents have a right to pursue their own dreams and interests, outside of the context of both the marriage and the family, and to continually affirm and define their unique identities
